For medical problems after-hours, call your medical provider home site (where you see your primary care provider).

All of the Kintegra Health medical facilities provide medical coverage 24 hours a day, 7 days a week. If you or your child has a medical problem at night, on weekends, or on a holiday when the doctor’s office is closed, you are still able to obtain non-emergency medical care. Call your doctor’s office to learn how to reach the After-Hours Nurse Line or the doctor on-call. You can also send a message through MyChart to reach a professional nurse who can help you or your child.

The nurse or doctor on-call will ask for information about the reasons that are making you or your child feel bad.

- The nurse will then decide if you need...
- ...to know that everything is okay.
  - ...to get medical advice on what to do.
  - ...to speak to a doctor.
  - ...to speak to a doctor tomorrow.
